Rhonda Davis, VRC Licensing (804-966-7415) will be at the stable area from 8 a.m. - 2 p.m. on race day. If fingerprints are needed, two forms of ID are required (please see the attached list of acceptable ID).

The Great Meadow racecourse was inspected on May 1, 2023 by Bobby Hilton and Adel Marquez.

Turf: Very clean mature stand of turf; fescues and Bluegrasses average 6" in height.

Smoothness: Aggressive off-season program has yielded great results in repairing old damage (ie hand fills, rolling, and aeration).

Compaction: 90 to 100 throughout (soft).

Moisture: Readings were high due to 3" of rain in the last 72 hours in addition to a solid month of aggressive irrigation. The underdrains are open and functioning great.

Check in with Clerk of Scales by 12 Noon to report engagement (s) and overweight, if any.
- Pre Race Exam:** Mandatory veterinarian pre-race exam for all horses. Examinations will begin at 8:30am and end by 11AM. Horses will be called up in race order. Horses on Lasix must be on the grounds four (4) hours prior to their scheduled post time, but no later than 10AM for pre-race exams.
- VRC Licenses:** All owners, trainers, riders and grooms participating in the Virginia Gold Cup races are required to be licensed by the Virginia Racing Commission (VRC).

Admittance to the barn area is restricted to any individual 15 years or younger.

License forms and instructions can be accessed at www.vrc.virginia.gov.

There are no license fees, and all participants will be issued a three-year license. Please note that all first time participants must be fingerprinted upon making their initial application and pay a \$30 processing fee.

VRC Staff will be on-site at the Spring House May 4 & 5 from 9-5 for licensing. All licensing to be completed by 5pm on May 5, 2023. Grooms must have a VRC license unless they have a current license from another jurisdiction with them. Day passes will be issued and BOTH must be visible to VGCA Security for access.

VRC license must be visible AT ALL TIMES to the Security Staff.

Third Party Furosemide (SALIX) Administration:

Horsemen are reminded that third party administration of furosemide (Salix) is in effect at this race meet. Please refer to the NSA's website (nationalsteeplechase.com) for complete details of the NSA Medication policy. Contact Dr. Jeff Witwer (803-243-0328) with questions.

Saddling:

ALL HORSES WILL BE SADDLED IN THE BARN BEFORE EACH RACE ~ NO SADDLING IN THE PADDOCK. Horses will be led to the paddock TOGETHER before each race. The trainer or their licensed designate will be responsible for transporting the tack after weighing out back to the barn for saddling. Jockeys are not allowed in the stabling area. If trainers have multiple horses in a race or horses in back-to-back races, please make appropriate plans as it is imperative to stay on schedule.

Foal Papers:

No longer required to be on file with the Horse Identifier at the races provided the horse can be properly identified by tattoo or microchip. A one-time exception may be made provided the horse can be identified by its markings.

Scratches:

All scratches after 10am Wednesday, May 3, must be made no later than 11AM on race day.

Heath Certificate:

Horses shipping to the Virginia Gold Cup must have a Health Certificate dated within the last 5 days with the following information.

- Originated barn location with status on active or suspect case of Herpes Virus
- Vaccination date for EHV-1 that is dated no less than 7 but no more than 120 days.
- Coggins test conducted within 12 months.

Stabling:

Stalls & a bale of straw will be provided with each entry. Contact James Piper at 571-439-4839 if you are planning to bring an AE horse as well. Please discard all wraps and supply materials in a trash can, not in the stall along with any other trash generated during the day.

Schooling:

NO SCHOOLING ON THE COURSE RACE WEEK. The course will be available for walking on Thursday, May 4, 2023 beginning at 11am.

Refreshments:

Grab & Go breakfast and lunch will be available in the barn area for all trainers and grooms along with cold beverages.

The second form of identification can come from either the Photo Identification or Secondary Identification listing. Only original documentation accepted; no photo copies will be allowed.
