ATTENTION JOCKEYS:

There will be a mandatory meeting of all jockeys with the stewards at the jockey's quarters at 11:45 a.m.

All jockeys are reminded to check in with the Clerk of Scales one hour prior to post time of the first race and report his/her engagement(s) and overweight, if any.

JOCKEYS MAY NOT WEAR ADVERTISING ON THEIR BRITCHES. NO EXCEPTIONS.

NOTE: Smoking and/or vaping is prohibited in the barn area and jockeys quarters.

Riders are restricted to the jockeys quarters and saddling area until after their last mount.

The jockeys tent will be located by the paddock at the stables.

The Clerk of Scales will be at the saddling paddock for weighing out, and at the tower for weighing in.

Pre-Race Exams & Lasix Information:

Mandatory pre-race exams will begin at 8:30 am.

Bandages are not permitted during the examination.

ALL HORSES MUST BE ON THE GROUNDS BY 10:30 A.M. REGARDLESS OF LASIX TIME.

If your horse's Lasix time is earlier than 10:30 A.M. it must be on the grounds 4 hours prior to post time of their scheduled race.

THIRD PARTY FUROSEMIDE (SALIX) ADMINISTRATION: Horsemen are reminded that third party administration of furosemide is in effect at this race meet. See Schedule. If your horse(s) have not previously run on Lasix, a NJRC declaration form MUST BE SUBMITTED PRIOR TO ENTRY. If you have ANY question about whether your horse is eligible to run on Lasix, please call or text the NJRC Lasix verifier, Debbie George, at 732-513-9942. Lasix administration will be conducted by Dr. Celeste Kunz (908-875-5075). Minimum Lasix dose is 3cc, maximum dose is 10cc.

THE FLAT RACE WILL BE RUN LASIX FREE.

THE FLAT RACE WILL FOLLOW THE HISA SHOE POLICY.

HISA's Racetrack Safety Program prohibits traction devices on forelimb and hindlimb horseshoes during racing. Traction devices include, but are not limited to rims, toe grabs, bends, jar calks, stickers, traction nails and/or mud nails.

SADDLECLOTHS: All saddlecloths will be distributed at the time of saddling on a race by race basis. You will not be able to pick up your saddlecloths in advance. Grooms will also pick up their number

Wristbands will be distributed in the NJRC Licensing tent at time of licensing. If you already have your NJRC license please stop at the tent to pick up your barn access wristband.
