VET EXAM: There will be a mandatory pre-race veterinary jog exam with Dr. Ian Harrison. Bandages are not permitted during the examination. LASIX HORSES MUST BE ON THE GROUNDS FOUR (4) HOURS PRIOR TO POST TIME FOR THEIR SCHEDULED RACE. ALL HORSES MUST BE ON THE GROUNDS TWO (2) HOURS PRIOR TO POST TIME FOR THE FIRST RACE UNLESS EXCUSED BY THE STEWARDS FOR EXTENUATING CIRCUMSTANCES.

Foal papers are not required to be on file with the Horse Identifier at the races providing the horse can be properly identified; tattoos and microchips are required for all horses, with a one-time exception providing the horse can be identified by its markings.

All scratches must be made no later than one hour prior to post time for the first race.

Notes: The Course has vastly improved over the last 3 years. It has been groomed fertilized

and over seeded. There is a nice fresh crop of grass growing currently and expecting rain next

week.

Updates: The Blue Ridge Course at Woodley Farm was inspected on Sunday, March 24, 2024, after 6:00pm that evening. The course has been evenly moved before the inch and quarter of rain it received on Friday night and Saturday morning. A fresh growth of green grass is evident from a week of sun and the weekend rain. There is in the forecast some additional rain showers this week and cool weather, high 40's and low 50's. Compaction ranged between 85 to 95, average 89 and a moisture reading of 8. The going should be near excellent race day.

The sanctioned races should be the second and fourth as indicated in the VPPF Condition Book but could change depending on the point-to-point entries. Post times are to be 1:35 for the second and 2:45 for the fourth.

Directions to the course:

From Route 7 and Berryville; take 340 south for 3.5 miles, left on Bishop Meade Road, .1 mile and left onto Briggs Road .8-mile Woodley farm is on your left.

From Winchester; east on 50 12 miles, left onto 340N for 4 miles, right on Bishop Meade Road .1 mile, left onto Briggs Road .8-mile a and turn into Woodley on your left.

From Middleburg; West on 50 for 18 miles, right on 340N for 4 miles, turn right onto Bishop Meade Road.1 mile, left onto Briggs Road.8 mile then turn into Woodley Farm on your left.
