Foal papers are not required to be on file with the Horse Identifier at the races providing the horse can be properly identified; tattoos and microchips are required for all horses, with a one-time exception providing the horse can be identified by its markings.

The Old Dominion Hounds racecourse at Ben Venue was inspected on Easter Sunday, March 31, 2024, after 3:00 p.m. by Don Yovanovich.

This rolling course has a beautiful cover of grass about 6 to 7 inches in height. The cushion is good, and the current weather has helped the grass turn green. The entire course is smooth and has been recently chain harrowed. The weather forecast for tonight, Sunday the 31st is some showers and then additional showers Monday, Tuesday and Wednesday. This course can take a lot of rain because of its topography. The outer loop of the timber course can be a little softer and a little wetter than the main course. Moisture: average 8.25 average wet

Compaction: 99 good
