**REMOVAL FROM HISA VET'S LIST**

All pre-race veterinary scratches, including illnesses, must have a declaration from your private veterinarian entered into the HISA record under the record type "mandatory attending vet inspection" to be removed from the HISA vet list/be eligible to run.

**WORKOUT REPORTING FOR IN TODAY HORSES**

Please make the clockers aware of horses that are entered and have made the overnight for races in the coming days when calling in workouts to the clockers.

**HISA RULE UPDATE**

Effective July 8, 2024, Pursuant to HISA rule 2240 (2) Veterinarians list. Covered Horses placed on the Veterinarians' List for unsoundness, injury, or Epistaxis are prohibited from participating in a Workout for 7 days. Violations to this rule will result in fine.

**PADDOCK SCHOOLING**

Wednesday-Sunday - 10:30-11:30

**WORKOUT CRITERIA - IMPORTED HORSES**

The workout requirements will be waived for horses entering a race within 14 days of clearing USDA quarantine, provided that the country of origin's racing jurisdiction has no provision for timed workouts on a regular basis. After the 14 days have elapsed, a horse would need to show one published work of 3 furlongs or further within 30 days of the race, two published works within 60 days of the race, or three published works within 90 days of the race matching the distance requirements for domestic horses.

Please be cognizant of HISA shoe rules as it relates to turf racing. Only Queen's plate or similar shoes are allowed. No toe grabs (front or hind) are permitted. Please refer to HISA Rule 2276 for additional information.

**RE-ENTRY POLICY**

No horses are allowed to re-enter races while considered in-today horses, with the exception of a horse that is part of a coupled entry. A re-entered horse must scratch out of their original spot and run in the second spot, upon approval of the racing secretary and Board of Stewards.

**NYRA SHUTTLE - BELMONT BASED HORSES**

When entering a Belmont based horse a (S) needs to be placed on the Overnight if using the NYRA Shuttle. Trainers need to confirm arrangements for shipping from Belmont to Saratoga and back to Belmont. Contact NYRA Van Agent Gil Sandoval 347-865-1714 or the Stall Office. Preference given to horses listed on the overnight. For Sleeping Rooms contact Maria Rivera. (MUST bring own Bed). Note: You MUST have your own attendant with shank to ride with the horse.

**OFF-THE-TURF FIELD SIZE**

In races taken off the turf, the field size may expand to accommodate the maximum number of runners allowed on the main track for the off-the-turf distance.

**MAIN TRACK ONLY HORSES:**

Main Track Only (MTO) entries may be made and horses entered MTO will be drawn on the also-eligible list. MTOs will be expected to run if a race comes off the turf; however, if an MTO has entered back in a subsequent race and is in the body of the subsequent race, the horse will be an automatic scratch out of the initial MTO spot.

**HISA HORSE REGISTRATION**

All horses are required to be registered with HISA prior to their first published workout. Please ensure compliance by registering promptly.

**EXERCISE RIDER SAFETY EQUIPMENT**

Horsemen: please help ensure exercise riders are wearing compliant vests and safety equipment.

**RECOGNIZED PUBLISHED WORKOUTS**

Per order of the stewards: Published workouts from Westampton Farms Training Center will not be recognized in order to establish eligibility to run at NYRA tracks.

**SUBSTITUTE SILK FEE**

Beginning Thursday, April 4, 2024, the fee for using substitute silks will be \$100 per use. The fee may be imposed if the owner does not have registered and compliant silks in the colors room prior to the race.

**FOREIGN-BRED HORSES - COUNTRY CODE MUST BE USED**

CLAIMS - Any attempt to claim a foreign-bred horse must include the correct country code for that horse on the horse name line. Failure to do so will result in the claim being voided.  
 BILLS OF SALES, COGGINS, LASIX CERTIFICATES - all must also carry the horse's country code as part of the horse's name.

**HIWU TESTING PROGRAM**

HIWU's testing program includes the testing of selected horses after routine timed workouts/breezes (Post-Work). This testing is separate from Vets' List testing. Trainers will be notified of selection for Post-Work testing within one hour of a horse's completion of the breeze. A. Horses that are beaten by more than 12 lengths in FIVE consecutive starts, will be ineligible to race at NYRA until approved by the NYRA Veterinarian Department.  
B. Horses will be limited to FOUR starts in a rolling eight-week period.

**RACE DAY LASIX ADMINISTRATION**

A member of the trainer's staff must be present for a horse to receive Lasix on race day.

**INTRAARTICULAR ADMINISTRATIONS (Joint Injections)**

Effective 5/22, intraarticular administrations (joint injections) MUST be reported by your veterinarian to the HISA portal. Reports made to the ESAL will not be recognized. Such horses are ineligible to race or work off the vets list for 14 days and ineligible to breeze for 7 days.

\*\* It is against HISA rules to breeze a horse within 7-days of an intra-articular injection. If you inject a horse on Saturday, you cannot breeze the horse until the following Saturday. \*\*

**CLAIMED HORSE - BLOOD ANALYSIS TEST**

Effective 5/22, the test will be \$225.

**TRANSFER OF CLAIMED HORSES**

Per NYSGC 4038.4 - If a horse is claimed it shall not be sold or transferred to anyone wholly or in part (including trainer transfers), except in a claiming race, for a period of 30 days from the date of the claim.

**VET SCRATCHES**

Horses scratched by vets are placed on the vets list the day of their race.

**VET LIST BREEZES - MINIMUM 72 HOUR NOTICE REQUIRED**

All breezes for working off the Vet's List must be scheduled with NYRA Vets no less than 72 hours in advance of work.

**BY ORDER OF THE STEWARDS  
(PURSUANT TO NYSGC RULE 4033.8)**

Only equipment specifically approved by the stewards shall be worn or carried by a jockey or a horse in a race. No equipment change (including shoes) will be allowed once the overnight is published.

**RACE-DAY SHIP INS**

All horses shipping into NYRA racetracks must be on the grounds NO LATER than 9:00 a.m.

**TWO-YEAR-OLDS** are allowed on the grounds beginning Friday, March 1, 2024 with the Racing Secretary's approval.

**HORSE PATH PROTOCOL**

Jogging is not permitted on horse paths to and from the racetracks and jogging barns. Fines may be issued.

**ATTENTION JOCKEY AGENTS:**

It is solely your responsibility to confirm with the racing office if you are accepting mounts for your riders at NYRA tracks or accepting mounts at out of town tracks. Failure to communicate availability may result in fines.

**NYSGC Equine Medical Director Advisory:**

Guidance to Protect Horses Racing in Hot Weather On December 20, 2022, the US Food and Drug Administration (FDA) approved Zycosan (pentosan polysulfate sodium injection) for control of clinical signs associated with osteoarthritis in horses.  
<https://www.fda.gov/animal-veterinary/cvmupdates/fdaapproves-first-injectable> is the first injectable form of Pentosan to be approved for use in the horse by the FDA.

**ZYCOSAN ADVISORY**

Zycosan is being marketed for intra-muscular use in horses with osteoarthritis. Appropriate treatment of osteoarthritis should include both disease-modifying and symptom-modifying medication. Zycosan is a symptom-modifying medication. It will do nothing to modify the disease process of osteoarthritis, but will help to control the clinical signs (e.g.: lameness) associated with it. The Zycosan recommended treatment regimen is 1 intra-muscular injection of Zycosan (3mg/kg) once every 7 days for a series of 4 treatments. Individuals contemplating the use of Zycosan in horses training and racing at New York racetracks should be aware of the following:

Given that Zycosan is not currently listed in the Rules and Regulations Chapter I (Division of Horse Racing and Pari-Mutuel Wagering) Subchapter A (Thoroughbred Racing) 9 NYCRR 4043.2, paragraph (h) and Subchapter B (Harness Racing) 9 NYCRR 4120.2, paragraph (n) apply: No other drugs or medications (including procaine) may be administered by any means within one week of the scheduled post time of the race in which the horse is to compete. By rule, intra-muscular administration of Zycosan is not permitted within 7 days of the scheduled post time of the race in which the horse is to compete. Additionally, medications administered by an intra-muscular route may have variable absorption and elimination times. Repeated administrations of any medication can lead to accumulation of the drug in the system of the horse. For these reasons and until such time as administration studies can be performed to determine the elimination times for cumulative administration of Zycosan, the use of Zycosan in horses that are racing at New York racetracks is discouraged to prevent an adverse medication finding.

**SAME TRAINER ENTRY RULE CHANGE**

Effective at the start of the Belmont at The Big A meet (September 15th), the rule disallowing a trainer to have multiple entries of different owners in a race to the exclusion of another trainer's single entry is rescinded. Condition eligibility, then date preference, then same owner entries will determine which horses are drawn into a race.

**L-ARGININE ADVISORY**

On the advice of Dr. George Maylin, Director of the New York State Drug Testing & Research Laboratory, L-arginine should not be administered to a horse within 48 hours of the scheduled post time of a race.

**IN TODAY PLACARDS**

In today placards must be placed outside each stall for horses entered to race no later than 6am the morning of race and be left hanging until the in today horse has left to assembly barn. Failure to have these placards on display by 6am or to display them on an incorrect stall will be reported to the Stewards. A fine or scratch may be issued by the NYRA Steward if the in today sign is not correctly displayed.

**EFFECTIVE JULY 29, 2022 ON HISA RULE 2276 (Horseshoes)**

RULE 2276 shall not be enforced for horses RACING ON DIRT SURFACES that are shod on the HINDLIMBS with traction devices in the form of EITHER A FULL OUTER RIM SHOE (UP TO 4MM IN HEIGHT) OR A TOE GRAB (UP TO 4MM IN HEIGHT). All other provisions of Rule 2276 shall remain in full force and effect. Enforcement of Rule 2276 will begin as previously announced on Monday, August 1, 2022.

**ALTERING SEX OF HORSE**

If a horse is gelded or castrated on the premises of any NYRA racetrack, or under the jurisdiction of the State of New York, the trainer shall report the alteration within 72 hours.

**IF THE TRUE SEX OF A HORSE IS NOT CORRECTLY IDENTIFIED IN THE OFFICIAL PROGRAM FOR THE RACE IN WHICH THE HORSE IS ENTERED, THE TRAINER OF THE HORSE SHALL BE SUBJECT TO A MINIMUM FINE OF \$250.** This fine is at the discretion of the Stewards, if mitigating circumstances can be demonstrated by the trainer.

**NO CELL PHONE USE** while on horseback, including ponies. See page 21 of the condition book under safety protocols.

**PIN FIRING and FREEZE FIRING** of the shins (dorsal surface of the third metacarpal/metatarsal bones) are prohibited beginning July 1, 2022.

**WAIVER CLAIMING EXEMPTION - PER HISA REGULATIONS**

The waiver claiming exemption eligibility is now available for horses which have not started in 120 days or more (previously 180 days or more)

**HISA APPROVED CLAIM SLIPS**

Claim slips with HISA approved language must be used.

**SHOCK WAVE - PER HISA REGULATIONS**

Horses treated with Shock Wave Therapy shall be placed on the Veterinarians' List for 30 days and shall not be permitted to Race or breeze for 30 days following treatment.

**POOR PERFORMANCE**

Horses put on the poor performance list (beaten 25 or more lengths, at stewards' discretion) must work a 1/2-mile in 53 seconds or less or 5 furlongs in 1:04 or less to be taken off the list and be eligible to enter.

**SECTION OF RULE 4003.53 - GAP OF ATTENDANTS**

A trainer desiring to engage a horse in a workout shall, prior to such workout, cause the following to be specified to a workout coordinator: the name of the horse, the distance the horse will workout and at what point on the facility the workout is intended to begin.

**GATE APPROVAL - FIRST TIME STARTERS**

Trainers must verify horses have been gate approved BEFORE entry. Entries will not be accepted on horses not approved. Please be prepared to submit gate cards or approval. Contact Hector Soler - 516-495-0577

**CLAIMS - AUTHORIZED AGENTS**

Authorized agents submitting claims must be licensed by the NYS Gaming Commission as an authorized agent. Please check with the NYSGC before submitting a claim.

**CLAIM SLIP ACCURACY**

Claim slips must be filled out in their entirety and with accuracy, or the claim will be voided; this includes, but is not limited to, owners' names/stable names and reference horses.

**RECENCY**

**MORE THAN 180 DAYS:**

Horses which have not started in more than 180 days or less than 365 days must be presented to the NYRA Veterinarian prior to racing.

**MORE THAN 365 DAYS:**

Horses which have not raced in 365 days will automatically be added to the Veterinarians List and must satisfy the same requirements for removal from the Veterinarians List as horses designated as unsound. If a start has not been made within 60 days of the NYRA Veterinarians clearance then the horse must be re-examined and approved to race by an official NYRA Veterinarian.

**HORSES MAKING 1ST START AFTER JAN. 1 OF THEIR 4YO YEAR:**  
Horses which have not made a start prior to Jan. 1 of their 4 year old year will automatically be placed on the Veterinarians List and must satisfy the same requirements for removal from the Veterinarians List as horses designated as unsound. If a start has not been made within 60 days of the NYRA Veterinarians clearance then the horse must be re-examined and approved to race by an official NYRA Veterinarian.

**KEEP BELMONT BEAUTIFUL**

All manure must be placed inside the proper containers. Areas around the containers must be raked and kept clean. All horses must be washed on the wash racks. Hose lines around the barn area can not be left running. Failure to comply will result in fines.

**JOGGING BARN POLICY** - There is no passing of horses allowed while using the jogging barns. Horses must stay in single file.

**IN-TODAY TRAINERS**

Race-day horses must be at the assembly barn 45 mins prior to their post

**FOAL PAPERS - FIRST TIME STARTERS**

All First Time Starters must have papers on file in order to be eligible to start. Additionally, registration papers will not be released from Horse ID without trainer approval.

**DIGITAL FOAL CERTIFICATES**

The Jockey Club registry issues digital foal certificates for foals of 2018 and later. Digital certificates are stored on the Registry's website at [registry.jockeyclub.com](http://registry.jockeyclub.com). Assign digital certificates to BELMONT AT THE BIG A as the Certificate Manager. For 6yos and up, continue to deliver paper certificates to Horse ID. If you have questions, see the digital certificates FAQs at [registry.jockeyclub.com](http://registry.jockeyclub.com) or contact the Registry office: by email - [inquiries@jockeyclub.com](mailto:inquiries@jockeyclub.com) --- by phone - (800) 444-8521.

**NYRA STAKE RACES - LASIX POLICY**

The use of Lasix is not permitted within 48 hours of post time in all NYRA stake races.

**SILK ROTATION BETWEEN PARTNERS**

The managing partner must notify the NYRA Clerk of the Course, Kelly Gecewicz, by time of entry, as to which silks will be worn for a specific race for the first initial start at a NYRA track or if a change in silks is to be made.

**ATTENTION TRAINERS AND VETS**

Recently, there have been some questions posed regarding the Commission's rules pertaining to the use or possession of growth hormone or growth factors by trainers or veterinarians at New York racetracks and while training horses to race in New York. This memorandum is intended to provide clear notice of the Commission's Thoroughbred regulations pertaining to possession or use of growth hormone or growth factors.

All forms of growth hormone and growth factors (e.g., Medivet SGF1000 RMR, TB1000) are PROHIBITED by Commission Rule 9 NYCRR 4043.12(a), which prohibits at any time the possession on the racetrack or use anywhere of these substances. See S2(5, 7) of ARCI "Prohibited List" annexed to Model Rule ARCI-001-015 version 7.0. This current rule has been in effect since August 2018. These substances were prohibited by a previous version of this rule in July 2012.

A horse in violation of this prohibition will be BARRED from racing until it is certain that the horse is no longer affected by the growth hormone or growth factor, and no less than 30 days to 180 days depending on the trainer history of equine drug violations, 9 NYCRR 4043.12(e)(1). The license of the trainer, and other responsible persons, in the absence of extraordinary mitigating circumstances, will be REVOKED. Id. at (2). Certain substances (e.g., Interleukin Receptor Antagonist Protein (IRAP), Protein Rich Plasma (PRP), and Autologous Conditioned Serum (ACS)) that are listed on the ARCI Prohibited substance list MAY be used, provided that conditions for restricted therapeutic use are met. 9 NYCRR 4043.12(b).

**BY ORDER OF THE STEWARDS**

In all allowance/optional claiming races, once the overnight is out, there can be no change in regard to the condition the horse was entered for (allowance conditions or claiming price); regardless of it being a trainer's error or a racing office error.

**HORSEMAN'S ADVISORY:**

The application of any type of topical medication designed to alleviate pain, soreness or tenderness of the feet of horses (e.g.: Jim Ricken's Foot Formula #1 or Hawthorne Products Hoof Freeze Solution) on race day is forbidden.

A 1.5% aftercare assessment will be added on top of the claiming price for all claimed horses.

**SHIPPERS**

Please contact the stall office (516-325-2395) prior to arrival if shipping to a private barn.

**CRYO FREEZE**

Any Cryo Freeze therapy must be done by a Licensed Veterinarian.

**WORKOUT REQUIREMENTS**

Entries will not be accepted for any horse requiring a workout. Please confirm a workout has been published prior to entering.

**LASIX and OFF LASIX CERTS - NOT ACCEPTED DAY OF ENTRY**

Lasix certs and Off Lasix certs must be submitted PRIOR to day of entry. Incompletely or inaccurately filled out slips will be rejected.

**GELDINGS**

New geldings must be reported by trainers within 72 hours. Horses coming from farms as geldings must be reported by trainers prior to entry.

**OWNER CHANGES**

No change of ownership will be done without a fully completed Bill of Sale signed and notarized by both the actual buyer(s) and seller(s). No agent signatures. No change of ownership after the close of entries. No change of ownership while a horse is in jail. Bills of sales must be on file prior to entry. Failure to comply will necessitate a scratch.

**TRPB DIGITAL TATTOO - 2024 Update - Aqueduct**
