

## Stewards Advisory Committee Rulings: Far Hills Saturday, October 19, 2024

#### First Race

Jockey Harrison Beswick was fined \$250 and suspended one day, Sunday, October 27, 2024 for seven whip strikes aboard Hidden Path, one over the limit.

Jockey Bernie Dalton was fined \$250 and suspended one day, Sunday, October 27, 2024 for seven whip strikes aboard Southpaw Mike, one over the limit.

#### Fifth Race

Jockey Jack Kennedy was fined \$250 and suspended one day, Thursday, October 24, 2024 for seven whip strikes aboard Galvin, one over the limit.

Following an official hearing, held telephonically on Tuesday, October 22, 2024, jockey Graham Watters was fined \$1,000, \$500 each for two separate incidents at Far Hills where he disregarded the orders of and was disrespectful towards two Far Hills' volunteers, a clear violation of the NSA Code of Conduct.

We monitor and maintain this course and the turf 12 months per year. We have mowed regularly, over seeded, fertilized and paid careful attention to regular aeration (core and slice) and dragging. Attached are the results of the testing that took place on the morning of October 22, 2024. At testing, the turf is thick and green with virtually no weeds. We got very generous rain for two weeks the end of September and first few days of October. Despite the lack of measurable rain since then, the cool nights, heavy dew and sunny days have the grass continuing to grow. We will mow October 25 to a height of 8" and drag the course before Race Day. We will definitely drag the entire course on the afternoon/evening of Friday, November 1, 2024 before the Races the following day, November 2, 2024.
