Virginia General Preference will be used in filling all races. The preference, in order, will be Virginia Bred, Virginia Sired, Virginia Certified, and all other horses that are stabled or trained in Virginia or owned by Virginians.

Post times for the Colonial Downs jump races will be 10:45 AM (first), 11:20 AM (second), and 11:55 AM (third) during the meet. Colonial jump races are part of the regular pari-mutuel racing program and as such will follow all Virginia rules and regulations. Accordingly, all horses will be saddled in the paddock, and steeplechase jockeys will dress in the regular jockey's quarters.

All scratches and rider changes must be made by 10:00 AM on Thursdays. No changes will be allowed after this time. Riders must be named by the close of entries.

The Colonial Downs course will be set up with 5 flights of National Fences (3 down the back side and 2 on the front side). The first fence in the stretch the last time around will NOT be jumped.

ALL OWNERS, TRAINERS AND RIDERS MUST BE PROPERLY LICENSED WITH THE NSA AND VIRGINIA RACING COMMISSION BEFORE THEY WILL BE ALLOWED TO PARTICIPATE.

All participants (e.g., owners, trainers, assistant trainers, exercise riders, grooms, hot walkers, etc.) must be licensed by the Virginia Racing Commission. Owners and trainers must obtain a license before running their horses. If not, their horses will be scratched by the Stewards, with no exceptions. Every person accompanying or handling a horse in the Test Barn must display a current Virginia Racing Commission license.

WORKERS COMPENSATION

All Trainers must have a certificate, or other document, evidencing their maintenance of Workers' Compensation Insurance coverage for all their employees, in accordance with Virginia law and Colonial Downs' House Rules, that identifies the insurance carrier, the policy number, and its date of issue and coverage. Trainers shall also furnish Colonial Downs a copy of a notice to their workers' compensation carrier requesting the carrier to notify Colonial Downs if insurance coverage is cancelled. Failure to maintain a current and valid policy will result in eviction from the grounds. A current workers' compensation policy, indicating coverage specific to Virginia, or a signed RELEASE AND ASSUMPTION OF RISK WAIVER form, must accompany stall applications. (Go to

COGGINS TEST, HEALTH CERTIFICATE AND INOCULATIONS

All Horses, including stable ponies, entering the Racetrack grounds must have a health certificate and required vaccinations, which shall include: (1) Certificate of veterinary inspection (Health Certificate) within the prior 3 days; (2) Verification of EEE/WEE/WNV (encephalitides), rabies, and tetanus vaccinations within the prior 12 months; (3) Verification of Influenza and Rhinopneumonitis vaccinations within the prior 120 days; and (4) Verification of Negative Equine Infectious Anemia (Coggins) Test valid through the entire meet. A printed copy of the Coggins test must accompany the Health Certificate and be attached to the horse's Jockey Club Digital Foal Certificate. Horses not current on flu/rhino, need to be vaccinated immediately, and documentation given by the attending vet directly to the VRC Equine Medical Director. Horses without a current vaccination record will not be allowed to enter.

TRAINER NOTICES

Trainers must be in their assigned stall(s) no less than 5 hours. prior to first post. Also, the trainer shall have a representative available to assist the VRC veterinarian with the pre-race exam. If there is a problem with your stall please contact the racing department. If you wish to ship in to another trainer's barn you must obtain permission from the stall superintendent.

All horses running at Colonial Downs must be tattooed or microchipped, and be on the grounds five (5) hours prior to the first post.

Furosemide Treatment:

For eligible horses, furosemide will be administered by a single dose intravenously no less than four (4) hours prior to post time for the race in which a horse is entered. The furosemide dosage administered shall not exceed 6.0 ml (300 mg) and shall not be less than 3.0 ml (150 mg). Lasix is prohibited in all stakes races, including steeplechase.

Lasix Administration Times:

NSA Race 1 - Post Time 10:45 AM - Recommended Lasix Time 5:45 AM

NSA Race 2 - Post Time 11:20 AM - Recommended Lasix Time 6:20 AM

NSA Race 3 - Post Time 11:55 AM - Recommended Lasix Time 6:55 AM

RIDER NOTICES

All jump riders must ride in a helmet approved by the NSA and use a ProCush Whip. All riders are required to report to the jockeys' room no later than two (2) hours before post time for the first race. The NSA whip rule will be in effect at Colonial Downs.

PURSE DISTRIBUTION

All purse monies will be distributed through the NSA Central Bookkeeping System as follows: 60% to the winner, 18% to second, 10% to third and 7% to fourth. A \$1,200 participation incentive will be paid to owners that finish after fourth place.

All trainers will receive \$300 per race regardless of the finish to be paid by the Colonial Downs Bookkeeper.

The NSA will deduct an administrative fee equivalent to 3% of the purse from owners whose horses earn a portion of the purse. Runners Reward applies, with all fees waived for any horse which runs and does not earn a portion of the purse.
