Racing Officials: Officials Meeting 11:30 am at the Tower

Arrival Times:

- All horses, other than those running in the John Forbes Memorial Flat Stakes, participating in the Far Hills Races on October 18, 2025, must be on the Association Grounds, and checked in at the stable area with the safety steward, not later than 12:50 PM on Friday, October 17, 2025. This is 24 hours prior to post time of the first race on Saturday. There will be no exceptions to this order and tardiness to the grounds may result in a scratch.
- Vans/vehicles and tack boxes will be subject to search per NSA Rules Of Racing while on Association Grounds during the Race Period, 24 hours before post time for the first race Saturday.
- Horses running in the John Forbes must be on Association Grounds no later than 9:00 AM Saturday. The Forbes is a non-Lasix stakes race.
- All vans arriving Friday, October 17 must use Gate 2 off Route 202.

ABSOLUTELY NO COMPANION ANIMALS

Licensina:

- All Owners, Trainers, Assistant Trainers, Jockeys and Grooms participating in the Far Hills Race Meeting are required to be licensed by the New Jersey Racing Commission.
- The easiest way to obtain a license is by going to the Commission's website at NJRC
 LICENSING. Grooms will no longer have reciprocity with other racing jurisdictions.
- Please complete your forms in advance of your arrival at Far Hills. This will expedite the process on race day. **NJRC will have a licensing tent located in the barn area.** The licensing area will be staffed on race day only, beginning at 8:30 a.m.
- Payments can be by cash or check. If using checks, please have 2 separate
 checks for licensing and fingerprints. Checks are to be made payable to the New
 Jersey Racing Commission.

 Any trainer or owner who does not have his/her fingerprints on file in NJ or the Racing Compact needs to if they are running at Far Hills regardless of whether or not that person is physically at Far Hills. You can get fingerprinted at many police stations, then email or text the image to Steve Pagano, NJRC Presiding Steward (609-372-3245, spag527@yahoo.com)

BARN ACCESS IS LIMITED TO LICENSED OWNERS, TRAINERS, GROOMS AND ASSOCIATED TRUCKING/SHIPPING PERSONNEL WITH FHRMA BARN ACCESS WRISTBANDS.

Wristbands will be distributed in the NJRC Licensing tent at time of licensing. If you
already have your NJRC license please stop at the tent to pick up your barn access
wristband. Tent opens at 8:30 am.

PLEASE REMIND YOUR SHIPPER TO PICK UP A WRISTBAND AT THE LICENSING TENT. NO ONE WILL BE ALLOWED IN THE STABLE AREA WITHOUT THE BARN ACCESS WRISTBAND.

Jockeys:

- There will be a mandatory meeting of all jockeys with the stewards at the jockeys quarters at 11:45 a.m.
- The Jockeys Tent will be located adjacent to the stable area paddock.
- There will be two Clerk of Scales locations. One at the Jockeys Tent for Weighing Out. One at the Tower for Weighing In.
- All jockeys are reminded to check in with the Clerk of Scales one hour prior to post time of the first race and report his/her engagement(s) and overweight, if any.
- NOTE: Smoking and/or vaping is prohibited in the barn area and jockeys quarters.
- Riders are restricted to the jockeys quarters until after their last mount.
- NO JOCKEYS WILL BE ALLOWED IN THE STABLING TENTS.

JOCKEYS MAY NOT WEAR ADVERTISING ON THEIR BRITCHES. NO EXCEPTIONS

Pre Race Exam:

- Mandatory veterinarian pre-race exam for all horses.
- Mandatory pre-race exams will begin at 8:00 am.
- Horses will be called up in race order. Bandages are not permitted during the exam.
- All FLAT horses must be on the grounds by 9:00 AM. Unless excused by the Stewards.

Health Certificates

- Horses shipping to the Far Hills Races must have a Health Certificate dated within the last 5 days with the following information.
- Originated barn location with status on active or suspect case of Herpes Virus
- Vaccination date for EHV-1 that is dated no less than 7 but no more than 180 days.
- Coggins test conducted within 12 months.
- Rectal Temp of each horse at time of examination

LASIX

- THIRD PARTY FUROSEMIDE (SALIX) ADMINISTRATION: Horsemen are reminded that third party administration of furosemide is in effect at this race meet. See Schedule. If your horse(s) have not previously run on Lasix, a NJRC declaration form MUST BE SUBMITTED PRIOR TO ENTRY. If you have ANY question about whether your horse is eligible to run on Lasix, please call or text the NJRC Lasix verifier, Debbie George, at 732-513-9942.
- Lasix administration will be conducted by Dr. Celeste Kunz (908-875-5075). Minimum Lasix dose is 3cc, maximum dose is 10cc.
- THE FLAT RACE WILL BE RUN LASIX FREE.

Saddling:

- ALL HORSES WILL BE SADDLED IN THEIR STALLS.
- NO JOCKEYS WILL BE PERMITTED TO SADDLE HORSES
- All saddle cloths will be distributed at the time of saddling on a race by race basis.
- You will not be able to pick up your saddle cloths in advance.
- Grooms will also pick up their number pinneys at this time.
- Horses will proceed to the Stable Area Paddock to assemble in numerical order prior to moving to the Tower Paddock.
- Horses are to leave the stable paddock in sequential, saddle cloth numerical order.

BEST TURNED-OUT AWARDS:

\$200 cash prize awarded to the Groom of the Best Turned Out horse in each race.

Schooling: NO SCHOOLING WILL BE PERMITTED ON THE PROPERTY

The course will be available for walking on Thursday, Oct 17, 2025 beginning at 11am until 11:30 a.m. on Race Day.
