**Jockeys:** Mandatory meeting of all jockeys with the Stewards at 12 Noon.

Check in with Clerk of Scales by 12 Noon to report engagement (s) and overweight, if any.

Jockey Breathalyzer Screening

All jockeys will be required to undergo breathalyzer testing one hour prior to race time on race day. This procedure is in accordance with VRC regulation 11VAC10-60-10 V.1.A, which states that alcohol screening may be required by the Commission before competition. The screenings will be quick and discreet, and are part of our ongoing commitment to safety, fairness, and the integrity of the sport.

Pre Race Exam: Mandatory veterinarian pre-race exam for all horses. Examinations will begin at 8:30am and end by

11AM. Horses will be called up in race order. Horses on Lasix must be on the grounds four (4)

hours prior to their scheduled post time, but no later than 10AM for pre-race exams.

**VRC Licenses:** All owners, trainers, riders and grooms participating in the Virginia Gold

Cup races are required to be licensed by the Virginia Racing Commission (VRC).

Individuals 15 years of age and under are not permitted in the barn area.

License forms and instructions can be accessed at www.vrc.virginia.gov.

**Participant Licensing** 

The VRC will be on-site to license all participants on Oct 23 & Oct 24 from 9:00 AM to 5:00 PM. Please note that all participants must be fully licensed by Fri day at 5:00 PM in order to compete.

This includes trainers, owners, and other credentialed individuals.

VRC license must be visible AT ALL TIMES to the Security Staff.

#### Third Party Furosemide (SALIX) Administration:

Horsemen are reminded that third party administration of furosemide (Salix) is in effect at this race meet. Please refer to the NSA's website (nationalsteeplechase.com) for complete details of the NSA Medication policy. Contact Dr. Jeff Witwer (803-243-0328) with questions.

Saddling: ALL HORSES WILL BE SADDLED IN THE BARN BEFORE EACH RACE ~ NO SADDLING IN THE PADDOCK.

Horses will be led to the paddock TOGETHER before each race. The trainer or their licensed designate will be responsible for transporting the tack after weighing out back to the barn for saddling. Jockeys are not allowed in the stabling area. If trainers have multiple horses in a race or horses in back-to-back races, please make appropriate plans as it is imperative to stay on schedule.

**Foal Papers:** No longer required to be on file with the Horse Identifier at the races provided the horse can be

properly identified by tattoo or microchip. A one-time exception may be made provided the horse

can be identified by its markings.

**Scratches:** All scratches after 10am Tuesday, Oct 21, must be made no later than 11AM on race day.

**Heath Certificate:** Horses shipping to the Virginia Gold Cup must have a Health Certificate dated within the last 5 days

with the following information.

Originated barn location with status on active or suspect case of Herpes Virus

Vaccination date for EHV-1 that is dated no less than 7 but no more than 120 days.

Coggins test conducted within 12 months.

Stabling: Stalls & a bale of straw will be provided with each entry. Contact TC Williams at 703-843-6385 if you

are planning to bring an AE horse as well. Please discard all wraps and supply materials in a **trash can**, not in the stall along with any other trash generated during the day.

Schooling: NO SCHOOLING ON THE COURSE RACE WEEK. The course will be available for walking on Thursday,

May 1, 2025 beginning at 11am.

**Refreshments:** Grab & Go breakfast and lunch will be available in the barn area for all trainers and grooms along

with cold beverages.

Pets: PETS ARE NOT PERMITTED ON THE PROPERTY. Your dogs must be left at home.
